

8070 Ramzan Relief Package: Use The Web Portal To Check Your Eligibility

Description

The **Government of Pakistan** has introduced the **8070 Ramzan Relief Package** to provide financial assistance and essential food items to deserving families during the holy month of **Ramzan 2025**. The initiative aims to help **low-income** and poor households fight rising inflation by offering free or subsidized rations. The program is designed for those who are eligible. If you want to check your **eligibility and register** for the program, you can now do it online through the official web portal.

How to Check Eligibility for the 8070 Ramzan Relief Package?

To make the process simple and accessible, the government has launched an **online web portal** where applicants can check their eligibility and apply for the relief package. Follow these steps to check if you qualify:

Visit the Official Web Portal

- Open your mobile or computer browser.
- Go to the official **Ehsaas 8070 Ramzan Relief Package** website.

Portal: <https://pser.punjab.gov.pk/>

Enter Your CNIC Number

- On the portal, enter your **Computerized National Identity Card (CNIC) number** in the required field.
- Click on the **Check Eligibility** button.

Receive Confirmation

- If you are eligible, you will receive a confirmation message with further instructions on how to **collect your relief package**.
- If not, you may need to contact the local **Ehsaas program office** for further details.

Alternative Method: Check Eligibility via SMS

If you do not have internet access, you can check your eligibility by sending an **SMS**. Simply:

- **Send your CNIC number to 8070**
- **Wait for a confirmation message from the government**

If you are eligible, you will receive details about the nearest distribution center where you can collect your **Ramzan ration package**.

Who is Eligible for the 8070 Ramzan Relief Package?

The government has set certain **eligibility criteria** for the Ramzan relief package. Typically, you qualify if:

Criteria	Eligibility Requirement
Income Level	Below the poverty threshold
Program Registration	Registered in Ehsaas Program or BISP

Employment Status	Not a government employee
Taxpayer Status	Not a taxpayer

Yes, people registered under **Ehsaas and BISP programs** are **prioritized** for the relief package
