Common Reasons 9999 PM Roshan Program Application Rejection Reasons

Many applications are not approved due to common mistakes or failure to meet the government's conditions. The main reasons include:

- **Incorrect CNIC Number** – If your CNIC number is incorrect or has missing digits, your application will be rejected.
- **Wrong Name or Address** – If your name or address is not correct, your application will not be approved.
- **Wrong Mobile Number**-Incorrect mobile number or inactive phone
- **Wrong Address**- Incomplete address or missing details

Ineligibility

The program is only for low-income families. If an applicant's income exceeds the government's limit, they will not qualify. Conditions include:

- Must be a Pakistani citizen
- Belong to a low-income group
- Families with more dependents get priority

Duplicate Applications

Submitting multiple applications from the same household leads to disqualification. To avoid rejection:

- Only one person per family should apply
- Preferably, the head of the household should submit the application

Unverified CNIC

If the CNIC is not registered with NADRA or has incorrect information, the application will be rejected. Before applying:

- Verify CNIC details through NADRA
- Ensure CNIC is valid and linked to family records

Eligibility Criteria for 9999 PM Rashan Program Application Rejection Reasons

To apply successfully, you must meet the following requirements:

Basic Requirements

- Must be a Pakistani citizen
- Belong to a low-income family
- Families with more members have a higher priority
- CNIC must be valid and approved by NADRA

How to Avoid Application Rejection?

Provide Accurate Information

Steps to Follow

- Double-check CNIC number and name spelling
- Ensure your mobile number is active
- Fill in the correct home address

Verify Eligibility Before Applying	-Read and understand the program's requirements -Confirm that your income and family size match the criteria
Submit Only One Application Per Household	-Avoid sending multiple entries -Ensure no other family member has applied
Ensure CNIC is Verified	-Visit NADRA to verify CNIC details -Update CNIC before submitting the application

Step-by-Step Application Process

Understanding the process can help avoid mistakes. Follow these steps:

APPLY FOR 9999 Rashan Programme: ehsaas.punjab.gov.pk

Step 1: Registration

- Visit the official registration platform
- Enter required details like CNIC, name, and mobile number

Step 2: Submit Required Documents

- Provide proof of income and family details if required
- Ensure all documents are valid and updated

Step 3: Government Verification

- Authorities will review your application
- Background checks will confirm eligibility

Step 4: Approval or Rejection Notification

- You will receive an SMS regarding your application status
- If your application is not accepted, first find out the reason why it was not fully accepted, then try to correct any errors in it.
