What is biometric re-verification?

• **Biometric Re-Verification** means checking the identity of a person through their **fingerprints** and **thumbprints**.

» This is done through a modern system called **NADRA**, to ensure that the person receiving money from the **BISP Ehsaas program** is the **real beneficiary**.

« This method helps prevent issues like **fraud**, **misinformation**, or **duplicate registrations**.

In simple words, **biometric re-verification** confirms that the person who is **registered** is the **same person receiving the money**, and no one else is taking it in their place.

This process is a key part of **BISP 8171 Biometric Re-Verification August 2025** to ensure transparency and fairness in financial aid.

Why is this important in August 2025?

The **biometric verification campaign** has been **restarted in August 2025** under the **BISP 8171 Biometric Re-Verification August 2025** initiative.

This campaign was launched because many people's **information has become outdated** or they are **registered multiple times with the same records**.

People whose **identity cards have expired or are blocked** must get **re-verified**.

In some families, there have been **changes at home** such as:

Marriage

Birth of a new child

Death of a family member

The government wants to ensure that **only the rightful and deserving beneficiaries** are getting the financial support.

If you are already receiving support from **BISP** and do **not complete your verification on time**, your **payments may be delayed or stopped**.

Who should complete biometric re-verification?

Who Needs Re-Verification?

Under the **BISP 8171 Biometric Re-Verification August 2025** campaign, the following people must get re-verified:

People who received an **SMS from 8171** asking them to verify themselves

Those whose **BISP payments were stopped**

Individuals who recently updated their information in **NSER**

People who were earlier marked as **ineligible**, but are now eligible for the program

Even if you're receiving payments, as per the **new rules**, **biometric verification is now mandatory** for continued support

NSER Update vs Biometric Re-Verification

(BISP 8171 Biometric Re-Verification August 2025)

Point	NSER Update	Biometric Re-Verification
• Purpose	Updates household details (family size, income, etc.)	Confirms your identity using fingerprints
• Where Done	At BISP Registration Centres	At BISP or NADRA Biometric Desks
• When Needed	When there is any change in family info	When you need to confirm identity and receive payments
• Main Use	To keep your data accurate and updated	To ensure you are the right person to receive BISP payments

Timeline for biometric re-verification • August 2025

• BISP 8171 Biometric Re-Verification August 2025

• Biometric verification is now happening across the country

• **Start Date:** August 1, 2025

• **End Date:** August 31, 2025

• Important Instructions

• Don't wait till the last day!

• If you **do not complete your biometric verification before August 31**, your **payment may be delayed or stopped**.

• To keep receiving your support **on time**, make sure to visit the **nearest BISP or NADRA centre** and get verified **as soon as possible**.

Step-by-step guide to biometric re-verification

• Step 1: Check Eligibility via CNIC

• Open your **SMS app**, type your **13-digit CNIC number**, and send it to **8171**.

• You'll get a reply saying:

Already verified •

Need to update NSER •

Go for biometric verification •

• Step 2: Visit BISP or NADRA Center

• If verification is required, go to your nearest **BISP** or **NADRA office** during working hours.

Take your **original CNIC** with you.

• Step 3: Do Biometric Verification

At the counter, show your CNIC.

Place your **thumb/finger on the scanner**.

NADRA will check your **fingerprints**.

If they match, your **verification is done**.

© Step 4: Get Confirmation Message

You may receive an **SMS confirmation** or a **verification slip**.

→ This means your record has been **updated in BISP**, and you are **now eligible** for payment.

Required documents

Original CNIC (ID Card)

Must be **valid** (not expired)

This is **required for all applicants**

Children's Birth Certificate (B-Form)

Needed if **your children are part of the BISP program**

Old BISP Slip or Token

If you have any **previous payment slip or token**, take it with you

• Marriage or Divorce Certificate

If you were **recently married or divorced**, bring the official certificate

• Death Certificate

If a **family member passed away**, bring their **death certificate**

Photocopies of All Documents

Some centers may ask for **copies for record-keeping**, so keep them **ready in advance**

Taking complete documents will help your **BISP 8171 Biometric Re-Verification August 2025** go smoothly and without delay.

If your **biometric verification** is completed successfully:

ð??° Payments Will Restart

Your **BISP payments** will continue **as normal**.

ð§¾ Missed Payments Will Be Recovered

If you **missed a previous installment**, you may get **two payments together** (e.g., Rs. 27,000).

ð??• New Secure System

You will now receive **monthly payments** through a **safe and updated system**.

ð§?â?•ð??» Status Updated

Your name and status will be **updated in BISP and Ehsaas records**.

ð??© SMS Notification from 8171

You will get an **SMS from 8171** when your **payment is ready** for collection.

Tips for a smooth experience

â° Go Early

Avoid long queues by going **early in the morning**. It saves time and avoids delays.

ð?aa Carry All Documents

Bring your **original CNIC** and **photocopies** of all required documents (birth/marriage/death certificates if needed).

ð??? Protect Your Information

Never share your **ID card number** or **8171 code** with anyone. This keeps your information **safe from fraud**.

If you have questions or face any problem, contact the **official BISP helpline**. Do **not trust unknown people** or agents.
