The Growing Problem of BISP Agents Charging Extra Fees

Many beneficiaries have reported the same problem in the past few years. When they go to withdraw their payments, they are asked to pay a service fee, i.e., Rs.1000 or 2000. This problem is especially common in rural areas, where women often have limited knowledge of ATMs or banking systems. Scammers exploit this gap to help them receive what they are given.

- Payment agents who manage biometric machines or payment devices
- Bank guards who control queues outside ATMs
- Local shopkeepers using BISP devices for withdrawals
- Middlemen who pose as facilitators, journalists, or social workers
- While these individuals claim they are providing assistance, in reality, they are illegally taking money that belongs to the poorest citizens.

What Is BISP 2025 Full Payment Without Deductions?

In 2025, the government has reinforced transparency in welfare programs. The BISP 2025 full payment without deductions refers to receiving the full quarterly amount of Rs. 13,500. You are entitled to payments from vendors whose agents you are without deductions or commissions. This new policy will only ensure a smooth transition for deduction methods and will force direct payments through biometric authentication.

How to Receive Your BISP 2025 Full Payment Without Deductions?

Follow the steps to claim your full payment in 2025 without any hassle

- Verify eligibility
- Send your CNIC to 8171 from your personal mobile phone. You will receive a response confirming your eligibility and payment status.
- Visit the official payment center. Visit authorized HBL and NAB agents, ATMs, or the BISP for payment. Do not visit random shops or unregistered agents.
- Use Biometric Verification
- All payments require thumbprint authentication to prevent fraud. Make sure your fingerprint is scanned and payment is made in your name only.

Never Pay Extra Charges

The BISP 2025 full payment without deductions policy strictly forbids any agent or shopkeeper from charging a fee. The money you receive is 100% yours.

What to Do If You Face a Deduction?

If someone deducts your money:

- Call the helpline 0800-26477
- File a complaint online through the official website of BISP or register a support ticket at the nearest Tehsil Office.
- Take a photo or video of the person claiming the deduction to support your complaint.

Government Action Against Deductions in 2025

In 2025, corrupt agents and others have been suspended and arrested for extorting money from poor families. The full payment of 2025 is being made without deductions and is being monitored both through complaints from the police and by surprise visits by government teams. Anyone found guilty has been fined or blacklisted from the program.

Tips to Protect Yourself

Beneficiaries can take simple steps to stay safe:

Do Not

- Do not pay any extra charges to anyone.
- Do not trust strangers offering help near payment centers.
- Do not share your ATM PIN or CNIC copy without reason.

Do

- Only use official BISP payment centers.
- Take a trusted family member along if you are unsure about ATMs.
- Keep all receipts, slips, and SMS notifications.
- Immediately report if you face deductions.
- Awareness is your first line of defense.
