



BISP Appeal Process 2025?? How to Reapply If You Are Declared Ineligible

Description

Benazir Income Support Program (BISP) has launched a **new registration process** ?? **BISP Appeal Process 2025**, the aim of which is that those who were **not eligible earlier** can **apply again** and become **eligible**. Reapply for BISP if Previously Ineligible

If you were **previously ineligible**, you can now **reapply**. First, you will have to **update your eligibility**, i.e., you will have to complete your **identity card number**, **residence**, etc., and **health certificates**. After that, you will have to complete the **NSER survey** so that your **financial status** can be checked. It is very important to provide **information** during this survey so that you go to the office with your **updated documents**. This will help you complete your **registration process**. After this, you will undergo **biometric verification**, which includes **facial recognition** and **fingerprints**. After these steps, the office will inform you about the status of your **eligibility**.

Payment Methods After Successful Registration

After successful registration, you can receive **payment** through many methods.

• **Urban people** can receive money through **banks** or **ATMs**, and

• **Rural people** can receive money through **mobile wallets** such as **JazzCash** and **Daily Paisa**, etc.

If your **biometric verification** fails, you can receive **payment securely** through your **facial recognition**.

Important Steps to Avoid Disqualification in Registration

To avoid **disqualification** during the **registration process**, it will be very important for you to provide **information** so that it can be checked that there is no **difference** or **error**. You will have to provide the **necessary documents**, etc., correctly, completely, and perfectly. In addition, the **NSER survey** will have to be filled out completely and correctly so that **accurate information** about the **financial situation** of the household can be provided. These measures have been taken to **increase the chances of approval** and help **ease the registration process**.

The **government** has given a great opportunity to the people by providing a **re-application procedure** so that people can get **financial assistance** by re-applying. Those who were **previously ineligible** will now be able to apply again and get **financial assistance of Rs 13,500**.
