The Benazir Income Support Program and the Ehsaas Program are working together, so both have the same dynamic survey. The goal of both these programs is the same: to reduce poverty, identify poor households, and provide them with financial assistance.

Method

Steps

8171 Web Portal

1. Search for Ehsaas Dynamic Survey 8171 or go to the [official BISP website](#).
2. Enter your original **CNIC number**.
3. Your **eligibility details** will appear.

SMS Method (8171)

1. Send your **CNIC number** via SMS to **8171**.
2. You will get a reply with your **eligibility status**.

Eligibility Criteria for BISP Dynamic Survey 2025

Low Income: You belong to a poor family and your monthly income is low.

No Large Land Ownership: You should not have **300 acres or more** of land in your name.

Below Poverty Line: You are living below the poverty line.

No Government Employment: You should not be employed in any **government, semi-government, or autonomous** institution.

Widows Eligible: Widows can also apply for this program, but they will need to submit the **death certificate** of their husband.

Ehsaas Dynamic Survey 8171

Ehsaas Dynamic Survey Re-Verification Process:

Simple Process: If you want to **verify or re-verify** the Ehsaas Dynamic Survey, the process is **very simple and the same** for all.

Step 1: Just SMS your **National Identity Card Number** (in digits only) to **8171**.

Step 2: You will then **receive information** regarding your **re-verification**

Dynamic Survey Registration Process

You have to go to the official website of Benazir Income Support Program or Ehsaas Dynamic Survey, and there click on **Ehsaas Dynamic Survey Login**.

Ehsaas Dynamic Survey Form Online Submission Guide:

Step 1: Visit the provided link to access the **Ehsaas Dynamic Survey Form**.

Step 2: Fill the form with accurate information, including:

- Your **National Identity Card Number**
- **Family Information**
- **Contact Email or Mobile Number**

Step 3: Upload the **required documents** and **submit** the form.

Step 4: After submission, you will receive a **tracking code** **make sure to note it down** for future reference.

Final Step: For **biometric verification (fingerprint verification)**, visit the **nearest BISP or Ehsaas Center**.

Required Documents for BISP Dynamic Survey

You will need to provide the following essential documents at the time of registration in the BISP Dynamic Survey:

Please make sure you have the following documents ready and **complete** for a smooth registration process:

CNIC of yourself and **all your family members**

B-Form or Birth Certificate for children under **18 years**

Electricity and Gas Bill (as **proof of residence**)

Residence Agreement or other **proof of address** (rent agreement or ownership document)

Disability Certificate (if applicable)

Death Certificate (if the original head of household has passed away and you are registering in their place)

BISP Form online application

Step	Description
Form Submission	Visit the official website and fill out the registration form with accurate information.
Website Confirmation	After submission, a confirmation message will appear on the website.
Email Confirmation	You will also receive a confirmation email from the Ehsaas Dynamic Survey team.
Secure Registration	These confirmations ensure your registration is complete and secure.

What are the eligibility criteria for BISP 2025?

The **eligibility criteria for BISP** include low-income households, widows, persons with disabilities, and those not employed by the government. Eligibility is determined through the **Ehsaas Dynamic Survey 8171** data collected under the **BISP Dynamic Survey 2025**.
