2025 Update: 11 Key Reasons for BISP Payment Suspension

1. دفعہ • PMT Score Exceeding 32

Issue: If your Poverty Mean Score (PMT) exceeds 32, you become ineligible for two years.

دفعہ • Solution: Check your score by visiting the 8171 Web Portal or by sending an SMS with your CNIC number to **8171**.

2. دفعہ • NADRA Record Being Out of Date

Issue: If your children's B-form or your CNIC is not updated, the money may stop.

دفعہ • Solution: Visit the nearest **NADRA office** and get your record updated.

3. دفعہ • Buying a Vehicle or Property

Issue: Buying a vehicle, motorcycle, or land can make you ineligible.

دفعہ • Solution: If you've sold the items, reapply **after two years**.

4. دفعہ • Getting a Government Job

Issue: If you or your spouse get a government job, payments stop immediately.

دفعہ • Solution: Recheck eligibility **after leaving the job**.

5. دفعہ • Taking Pension

Issue: Receiving a government pension makes you ineligible for BISP.

دفعہ • Solution: If the pension has stopped, you can **reapply**.

6. دفعہ • Traveling Abroad

Issue: Traveling abroad (e.g., Umrah, visa, or for work) may stop your payments.

دفعہ • Solution: **Re-register** after returning to Pakistan.

7. Excessive Use of Mobile Wallet

Issue: Too many transactions from EasyPaisa or JazzCash accounts can lead to disqualification.

Solution: Avoid large financial transactions.

8. Registration with FBR

Issue: Being a taxpayer (registered with FBR) disqualifies you.

Solution: Clear your taxes or wait for re-evaluation.

9. No B-form for Children

Issue: Not having updated B-forms for children can stop your payments.

Solution: Update B-forms of all children at NADRA.

10. Not Participating in the Dynamic Survey

Issue: If you miss the BISP re-survey, you will be removed.

Solution: Go to the nearest BISP office and register again.

11. Financial Situation Improving

Issue: If your financial situation improves, you become ineligible for two years.

Solution: Reapply after two years if your situation changes.

Step-by-Step Guide to Restoring Your BISP Payments

Check Eligibility

SMS your CNIC number to 8171 or visit the BISP Website.

Update NADRA Records

Keep all your and your family's documents correct and up-to-date, including CNICs and B-forms.

Re-take the Dynamic Survey

☞ Complete a **new BISP survey** at the nearest office if required.

⚠️ • Avoid Disqualification

☞ Do not:

- Buy large items (☞ property, vehicles)
 - Travel abroad (☞, •)
 - Use mobile banking excessively (☞² EasyPaisa / JazzCash)

⚠️ Wait for Re-evaluation

☞ If your **PMT score is high**, you must **reapply after two years**.

☞ • **Look carefully** at the reasons listed above and take the necessary steps to fix the issue.

SMS your **CNIC number to 8171** or visit the **BISP Portal**.
