Who Can Benefit After PMT Score Increased to 35?

The **PMT score** is used by the government to check if a family is poor. In 2025, the PMT score limit has increased from **32 to 35**, which means **more families can now qualify for BISP aid**.

Categories Eligible After PMT Score Update 2025

Category	Description
Widows	Women whose husband has passed away
Divorced Women	Women who are legally separated from their husbands
Families with Special Children	Parents who have children with any form of disability

These families were not eligible before, but now, with the **PMT Score Increased to 35**, they are officially part of the **BISP 2025 Program**.
