How to Receive the Payment

- Those who are entitled to the aid will receive an **SMS from the number 9999**.
- After this SMS, **verify your biometrics**.
- After verification, you can **get five thousand rupees**.

Where to Collect the Payment?

You can get this **five thousand rupees** from:

- Any nearest bank
- Authorized cash center
- Easypaisa center
- Any shop designated by the government

Important Instructions

- First of all, get your identity card verified.
- If there is still a problem, contact the government's helpline.

This scheme is made for the poor so that they can meet their needs during Ramadan.

Government's Warning Beware of Scams and Frauds

Do not share your **identity card number or any other personal information** with anyone, otherwise, you may become a victim of fraud.

Important Safety Instructions

- If you receive a message **from any number other than 9999, ignore it**.
- **Do not share your CNIC number** or any other personal details with anyone.
- Be cautious, as **fraudsters may try to deceive you**.

Get Your Payment on Time

- Those who are entitled to the **Ramzan Relief Package of Rs. 5,000** should collect their money **as soon as possible**.
- Take full advantage of this government facility in the **blessed month of Ramadan**.

Ramadan Relief Package 5000 Support for Poor Families

Wait for the **SMS from number 9999** for verification. After receiving the SMS, take your **CNIC to a nearby bank or designated shop** and get it checked. Complete the **biometric verification** to confirm your identity. Once verified, you can **withdraw the money from a legitimate cash account**.

Steps to Receive the Payment

Step Details

- 1 Wait for the verification SMS from 9999.
- 2 Take your original CNIC to a nearby bank or authorized shop.
- 3 Complete biometric verification to confirm your identity.

- 4 Withdraw the money from a legitimate cash account.

Important Reminder

- If the money is **not withdrawn during Ramadan**, it will **go back to the government**.

The Prime Minister of Pakistan has declared the Ramadan Relief Package 2025 as a big help for millions of people. If you are eligible, you can also get five thousand rupees. By following the right procedure, you can also get five thousand rupees before the end of Ramadan. The **PMT Score Eligibility for Aid** ensures that only deserving families benefit from the scheme. If a family's **PMT score is above 32 or they receive other government aid**, they will not qualify for the **Ramzan Relief Package 5000**.

How do I check my NSER Registration for Government Relief?

To confirm your **NSER Registration for Government Relief**, visit a **local government office** or check online through the **BISP portal**. If you are registered and meet the criteria, you can apply for the **Ramzan Relief Package 5000**.
