Eligibility Criteria for Financial Assistance

In addition, it is also necessary to belong to a low-income family, otherwise, you will not be eligible for this financial assistance. It is also necessary to have a valid computerized identity card.

Important Eligibility Requirements

- Registration in the **Benazir Income Support Program** or similar schemes.
- Must belong to a low-income family.
- A valid computerized identity card is mandatory.
- Those not meeting these criteria will be ineligible for financial assistance.

Registration Process for Punjab Relief Program

- open the **SMS on your mobile phone**.
- write your **ID number** without any space.
- send it to **9999** from your registered mobile number.
- wait for the **message received to confirm** your eligibility.
